ORDER:

In the reference 1st read above, the Commissioner of Industries, A.P., Hyderabad has stated that due to imposition of power cuts, MSME are severely affected and thereby their production has come down severely affecting productivity of management and employees. The MSMEs have requested Government to provide sufficient Un-interrupted Power supply to all the SME units in the State and to lift the power cuts to run the SME units effectively.

2. In the G.O. 2nd read above, the Finance (Expr. I&C) Department has issued BRO for an amount of Rs.98.25 Crores towards 1st quarter Budget Estimates provision under the Head of Account "2852-Industries -80-General-800-Other Expenditure-GH-11-NSP-SH(13)-Power subsidy for Industries Grant in -Aid-312-Other Grants-in-Aid".
3. Accordingly, Government here by accord administrative sanction for an amount of Rs.98.25 Crores to the Commissioner of Industries, Hyderabad for release of the amount to APTRANSCO for providing Uninterrupted supply to SSI which have been registered as SSI with Industries & Commerce Department in relaxation of quarterly regulation orders and Treasury control.
4. The Commissioner of Industries, A.P., Hyderabad is requested to draw the amount and disburse the same to M.D. APTRANSCO, duly obtaining proper acknowledgement.
