**ORDER:**

In the G.O 1st read above, Government has sanctioned an amount of Rs.98.25 Crores to the Commissioner of Industries, Hyderabad for release of the amount to APTRANSCO, so as to provide uninterrupted supply to Small scale industries .

2. The Energy Dept in the reference 2<sup>nd</sup> read above has stated that the A.P TRANSCO and Discoms has generated additional 202.67 MW with RLNG to meet the power requirement for SSIs. The generated additional power was supplied to the units, during 1.4.2012 to 19.5.2012. The APTRANSCO / DISCOMS have requested to sanction the amount incurred towards reimbursement of RLNG cost.
3. In the G.O. 3rd read above, the Finance (Expr. I & C) Department has issued BRO for an amount of Rs.47.06 Crores as additional funds under the Head of Account "2852-Industries -80-General-800-Other Expenditure-GH-11-NSP-SH(13)-Power subsidy for Industries -310 - Grant in -Aid-312-Other Grants-in-Aid" in relaxation of treasury Control and quarterly regulation orders.

2. The Energy Dept in the reference 2nd read above has stated that the APTRANSCO and DISCOMs has generated additional 282.5 MW with RLNG to meet the power requirement for S&I. The generated additional power was supplied to the units during 1.4.2012 to 19.2.2012. The APTRANSCO & DISCOMs have requested to sanction the amount required towards the procurement of RLNG cost.
