In the G.Os 1st and 2nd read above, Government has sanctioned an amount of Rs.145.31 Crores to the Commissioner of Industries, Hyderabad for release of the amount to APTRANSCO, for the uninterrupted power supplied to the Small scale industries, during the period 1.4.2012 to 19.5.2012.

- 2. The Energy Department in the reference 3rd read above has stated that out of the total amount spent by the A.P Discoms / APCC, Government had released only a part of the total amount and requested to release the balance amount.
- 3. In the G.O. 3rd read above, the Finance (Expr.I & C) Department has issued BRO for an amount of Rs.11.94 Crores, as additional funds under the Head of Account "2852-Industries -80-General-800-Other Expenditure-GH-11-NSP-SH(13)-Power subsidy for Industries -310 Grant in -Aid-312-Other Grants-in-Aid" in relaxation of treasury control and quarterly regulation orders, subject to obtaining Supplementary grant during 2012-2013.
- 4. Accordingly, Government hereby accord administrative sanction for an amount of Rs.11,94,00,000 (Rupees Eleven Crore Ninety Four Lakhs only) to the Commissioner of Industries, Hyderabad for release of the amount to APTRANSCO towards un-interrupted power supplied to the Small Scale industries, during the period 1.4.2012 to 19.5.2012. The above amount is sanctioned in addition to the amount already released in the G.O's $1^{\rm st}$ and $2^{\rm nd}$ read above.
- 5. The Commissioner of Industries, A.P., Hyderabad is requested to draw and adjust the amount sanctioned in Para 4 above to the PD, Account No.GA.8 of APSFC preferring an adjustment bill with PAO. He is also requested to obtain supplementary grant during the financial year (2012-13).
